Question (a) Is the Ministry aware of challenges faced by fisheries sector in Goa, particularly concerning sustainability and fisherfolk livelihoods? If yes, provide details on initiatives supporting sustainable fishing practices and fisherfolk livelihoods.

Reply: Yes. Ministry of Fisheries, Animal Husbandry and Dairying is implementing Pradhan Mantri Matsya Sampada Yojana (PMMSY) - A scheme to bring about Blue Revolution through sustainable and responsible development of fisheries sector in India over a period of five years from FY 2020-21 to FY 2024-25 with an estimated investment of Rs. 20,050 crores. The scheme aims to take the fisheries sector to the next level. With its multi-dimensional interventions and activities along the fisheries value chain such as production and productivity, quality, technology, infrastructure and management, PMMSY aims to transform the fisheries sector and usher economic prosperity for fishermen, fish farmers and other stakeholders.

The scheme promotes sustainable fishing practices, reduce environmental stress and improve socio-economic condition of Costal fishermen.

Question (b) Is the Ministry taking initiative to address overfishing, habitat degradation, pollution in Goa's coastal waters? If yes, provide details.



Reply:

Yes, The Government of Goa proposed for development of fishing harbour/ fish landing centres at Malim, Cutbona, Chapora and Cortalim. Accordingly, Government of India sanctioned the said projects under the component on "Establishment of Fishing Harbours and Fish Landing Centres" of the centrally sponsored scheme during February, 2014 at an estimated cost of Rs. 8418 lakhs with a central share of Rs. 6,313 lakhs.
