Sir,

With reference to your above-cited RTI application, it is informed that the information requested pertains to a large volume of historical and legal documents including acquisition records, land ownership documents, government approvals, gazette notifications, registered deeds, and other related papers spanning several decades.

The said records are maintained in physical form, dispersed across various files, and not compiled in a single indexed file. Retrieval and collation of these documents in the specific format sought would, therefore, require substantial effort and time, and as such, disproportionately divert the limited resources of this public authority.

Accordingly, as per the provision under Section 7(9) of the Right to Information Act, 2005, you are requested to undertake a physical inspection of the relevant land records maintained at this office. After identifying the specific documents required, certified copies may be provided upon request and on payment of the prescribed photocopying charges as per the RTI Rules.

You may kindly contact the undersigned and indicate the preferred date of your visit at least two working days in advance, to enable us to facilitate access to the files for inspection. The inspection can be scheduled on any working day between 11:00 a.m. and 4:00 p.m., preferably before 31st August 2025.
