Question (a): whether the Government is aware of the frequent incidents of sea turbulence in various places including Palappetti, Ajmer Nagar, Veliamkode, Thannithura, Pathumuri, Arayan Kadappuram, Sulthan Valav, Vaadikkal, Pallivalappu, Vaakkad, Edakkappuram, Puthiyakadappuram, Anchudi, Cheeraan Kadappuram, Chaappapadi, Alungal Beach, other coastal places in Parappanangadi etc., along the Arabian Sea shores in the Ponnani Lok Sabha Constituency of the State of Kerala;

Reply: Information not available with the Institute.

Question (b): if so, remedial measures have been taken or are planned by the Government to protect the sea shore, including the construction of a permanent sea wall; and

Reply: Department of Fisheries, Government of India doesn't have the mandate to protect the sea shore, including the construction of a permanent sea wall.
